**500 Fitness:** A business opened in February 2015 has submitted a microenterprise grant for \$23,165.00 for additional equipment, storage, signage, décor, marketing, and additional computers and software. This business will create 5 part-time employment positions.

**Audit Presentation:** During the Finance Committee meeting Douglas Zimmerman of Toski & Co., PC presented the 2014 financial audit. A summary of the report was included in the Board packet and Director Moreau and Michael Zimmerman reviewed the findings of the report and answered all questions.

**Projects Review:** The Projects Review Committee did not hold a meeting in April.
