## **2017 Operations and Accomplishments Report**

Since 2004 Lumber City Development Corporation (LCDC) has supported over 90 business and real estate development projects in the City of North Tonawanda that have created quality jobs in a broad range of businesses. LCDC's mission is to assist business investment and growth that strengthens our local economy and community.

2017 was a successful year for business growth in North Tonawanda. LCDC assisted with numerous business start-up, expansion, and growth projects. A summary of the LCDC's annual activities is as follows:

January 18, 2017:

The Board reviewed accomplishments from 2016 and discussed goals and objectives of the Corporation for 2017.

The Board reviewed existing and on-going projects.

The Board reviewed a staff training and development plan.

February 15, 2017:

The Board reviewed the status of current projects.

The Board accepted a proposal from H. Sicherman & Co./The Harrison Studio for CDBG grant administration services not to exceed \$5,000.

The Board approved a \$200,000 loan request for Roger L. Urban, LLC., dba Platter's Chocolates.

The Board approved a 6 month extension of the existing commercial property listing agreement with Hunt Commercial Real Estate.

The Board approved hiring Bergmann Associates to complete the CDBG funded Oliver Street Needs Assessment for a fee of \$45,000.

The Board resolved to sponsor two decorative planters in North Tonawanda at a cost of \$300.

May 17, 2017:

The Board resolved to send a letter to the Riviera Theatre requesting information regarding the recent change in leadership and operations.

The Board resolved to become members of the Buffalo Niagara Partnership for the annual cost of \$800.

The Board reviewed information regarding the NYS Downtown Revitalization Initiative.

The Board reviewed information regarding potential applications to the 2016 NYS Consolidated Funding Application.

The Board was informed that LCDC had been selected for the Small Project of the Year Award from the NYSEDC.
